### Membership Application Deadlines and Late Fees:

Membership applications must be postmarked as follows:

1st Draw - On or Before November 18, 2011

2nd Draw - After November 18, 2011

Late Fee (\$50) Applies - After December 12, 2011

Non-member applications will follow the above draw schedule, but late fees do not apply.

Color Guards: A, Open, World → \$450.00, plus \$50.00 Surety Bond\* (\$50 dollar late fee if postmarked after December 12, 2011.)

Percussion: A, Open, World → \$450.00, plus \$50.00 Surety Bond\* (\$50 dollar late fee if postmarked after December 12, 2011.)

Color Guards: All Regional A Classes → \$425.00, plus \$50.00 Surety Bond\* (\$50 dollar late fee if postmarked after December 12, 2011.)

Percussion: Regional A → \$425.00, plus \$50.00 Surety Bond\* (\$50 dollar late fee if postmarked after December 12, 2011.)

Lines and Exhibition Units → \$400.00, plus \$50.00 Surety Bond\* (\$50 dollar late fee if postmarked after December 12, 2011.)

\*Surety Bonds are carried over from season to season. 2011 Members "In Good Standing" do not need to re-post their Bond.

Must be a member to perform at Championships. Fees paid as a non-member can be applied to a membership fee at a later date. All other rules/requirements apply.

## Insurance Liability:

All OIPA Members, NON-Members, and Guest Units shall provide proof of general liability and accidental medical insurance along with this application. The following are the minimum guidelines for the 2012 OIPA Competition Season.

**General Liability.** \$1,000,000 general liability coverage per school or organization. This coverage protects your unit, instructors, directors, and officers against claims of bodily injury liability, property damage liability and litigation costs to defend against such claims. This coverage will also allow any unit to rent rehearsal facilities as most require proof of coverage. School units should check with their district office to see if such coverage already exists. Most School Districts already have all of this taken care of.

**Accident Medical.** \$10,000 accident medical coverage per school or organization. This covers excess medical payments (instructors and performers) at all activities sponsored and supervised by the unit (rehearsals and performances) as well as travel in a group and travel individually from member's home. School units should check with their district office to see if such coverage already exists. Most School Districts already have all of this taken care of.

## Show Site and/or Housing Site Liability:

It is understood by the management of the Ohio Indoor Performance Association, that your unit and/or management of said unit (including Directors, Parents of performers, and any affiliate with this unit) will take full responsibility for any damages and/or any misconduct at housing, practice, or contest sites by members, parents and staff of said organization. It shall be the responsibility of said organization and not the Ohio Indoor Performance Association, for any vandalism, damage, or misconduct regardless whether said organization or its members are competing or simply in attendance at that show.
